How does the Research Project differ from an essay?

The Research Project is of course much longer than an essay, and you work on it for a much longer period. However, more than this, the Research Project is a different kind of work. The Research Project gives you the opportunity to decide for yourself what topic you will examine, and to explore it in much more detail. It also gives you the opportunity to go through the process whereby historians reconstruct the past. As historians, we recognise that history exists only in the present and in our heads; it is **actively constructed** and not simply rediscovered in the records of the past. Historical research involves a process of selection and interpretation, whereby historians examine the records of the past in order to construct an interpretation which they believe to represent the past in a meaningful way. In this process there is an active exchange between theory and evidence, whereby the historian develops theories about the past and tests them using the evidence available.

On the back of this form are some randomly selected titles of research projects submitted by Essex History students in recent years. The History Department keeps a copy of all firstclass projects from the past, and you can borrow them from Department Office.
